They function as deemed foreign territories with the objective of creating infrastructure to facilitate imports and exports while offering a range of streamlined services like customs clearance, cargo management, and tax benefits.

Integrated Trade Hubs


FTWZs are special zones focused on trading and warehousing, operating under the SEZ Act as deemed foreign territories to support global commerce.




General Way

- Value-Added Services (VAS) are not aallowed.




FTWZ Way

- Duties and compliance apply only when goods move from FTZ to DTA.
- Deferred duties help unlock working capital.
- Eliminates the need for a General Warehouse, improving supply chain efficiency.
- Unlimited Value-Added Services (VAS) available.












FTWZ Way

- VAS (Value Added Services) like CKD, SKD, and kitting are permitted.
- Additional services like quality checks are also available in the FTWZ.

Eliminates the need for companies to possess their own regulatory documents, simplifying compliance requirements.





